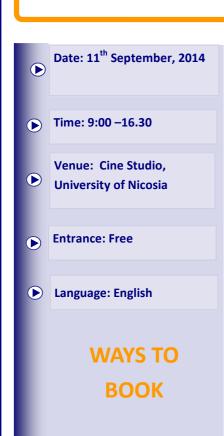

Cybersecurity standards development has accelerated in recent years, particularly in light of formation of the Cybersecurity Coordination Group (CEN/CENELEC/ETSI) in 2011, and the Cybersecurity Strategy of the European Union which promotes the widespread use of such standards within Europe. The purpose of this event is to bring together a number of high level experts in this field, with a view of presenting the current status of cybersecurity standardisation efforts in Europe, together with a wide ranging discussion on the applicability and practical issues associated with the adoption of such standards in Government and Critical Information Infrastructures. The target of the event is to stimulate both awareness regarding these standards, but also discussion on the feasibility of their widespread adoption amongst the event speakers and attendees.
